2A Legislature news

STATE legislature:

H.B 5364-5367 "Constitutional Carry" These bills first reported in this newsletter back in February, has been blocked by house republicans to bring it to a vote. The Speaker Pro Temp Pamela Hornberger claimed it had no support. (Rinos do it to us again).

Opinion #7304: The AG Opinion confirms that MCL 28.432 says that if you have an out of state CPL you **are** exempt from registering your pistols. It confirms a pistol can be legally possessed, even if it is not registered in Michigan. Theoretically an officer running the serial number of a pistol constitutes an unreasonable search. (see the 4th amendment US constitution)

2A Legislature news continued

Federal:

H.R. 7910 "Protecting Our Kids Act," (Nadler D-NY) Passed and sent Biden to sign. This bill has had modifications since the June newsletter. But it is only slightly less a violation of the 2nd amendment. Forget the fifth amendment the "red flag" portion removes the right to due process, and allows confiscation of private property without compensation (fifth amendment). The red flag part denies the right to a public defender further denying due process for the those that can not afford an attorney. This bill allows the attorney general to deny purchases of a firearm for any cause he feels like imposing (Shall not be infringed?). It takes away your 2nd amendment civil right if you have a misdemeanor. No other constitutional right is taken away for misdemeanor convictions.

2nd Amendment news

More Ammo Shortages: After banning Russian made ammo the Biden Regime is moving to restrict Lake City manufacturing, which is a supplier of about one third of the 5.56 ammunition made, from selling to civilians. I have purchased ammo from Lake City over the last 20 years as their prices were always great. This idea was started during the Obummer regime when they were going to ban "green tip" 5.56 ammo lying by claiming that they were armor piercing. The push back from the 2nd amendment community on that caused the resignation of the ATF director. Lake City is owned by the government but run by a civilian contractor.

No right to self defense: Hollywood elites (who can afford private security) want to remove the 2nd amendment from the constitution. Some are saying it is your right to be protected from gun violence. So are they calling for everyone to get a security guard paid for by the government?? They are demented enough that they believe the criminals will turn in their guns. I know history and prohibiting a commodity only creates a large criminal underworld that will supply it. (see the 18th amendment and how that worked out).

Inalienable rights dept.: The Supreme court ruled that the 2nd amendment is a full right. Therefore it would seem that **if** one does **not** have to apply for a permit from the government to exercise free speech, one would not have to apply for a permit to exercise the 2nd amendment right. However several states have stated they will ignore the supreme court decision.

This ruling will cause several lower court rulings to be vacated and remanded back for further consideration. The Maryland ban on assault weapons, and California's ban on "large capacity magazines", are two. This ruling clarifies that the second amendment is not a second class right that is subject to a different body of rules than the other rights. Expect second amendment organizations to challenge other rulings that were made under the erroneous idea the second amendment is "special".

Justice Clarence Thomas clarified that government can not simply restrict the 2nd amendment by stating their law is for a common good. They must demonstrate that the law or regulation is consistent with this Nation's historical tradition. Which should prevent restrictions on modern sporting rifles that the democrats keep calling "assault rifles".

Dumber than rocks: An anti-second amendment college professor, Ibram X. Kendi has stated on CBS Face the Nation anyone who supports the 2nd amendment is supporting slavery. Besides being totally ignorant of the true history of the amendment and the founding of the NRA he is a total idiot. But he is smarter than you as he is a "college professor".
