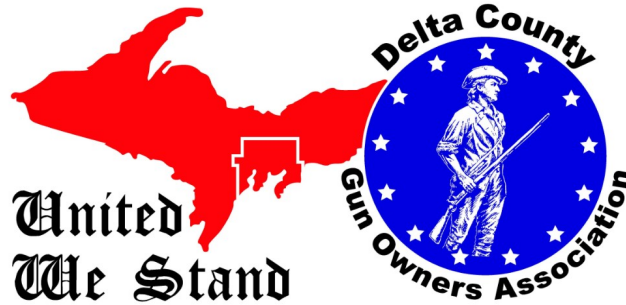


DCGOA DECEMBER 2021 NEWSLETTER

DCGOA NEWS

Notes from the November Meeting: Bob opened the meeting at 6:28, after the pledge to the flag, Larry read the minutes from the November meeting which was approved, Rich gave the treasurers report it was approved. Bob updated on the status of starting a Political Action Committee which need some members to volunteer to assist in creating. Bob reported the resolution to be brought before the county board to limit the mandating of masks is shelved. The Jim Groos Scholarship is moving forward but we need members to assist in creating an application form for this and to create a rules for winning the grant. An attorney will be consulted in setting up a DCGOA trust to put the clubs assets into.

Under new business the board positions of president and Member at Large will be up for elections in February. The Banquet committee will be starting up to start printing the application forms and mailing them out. We also will be acquiring the rest of the guns for the banquet raffles and games.

The Board reached out to Michigan Open Carry to see if they will need fund for upcoming activities. Other than pushing several bills through the state legislature they have no law suits in process due to the hostile Whitmer administration. We will send MOC and Great Lakes Gun Rights funds to help them offset their expenses in attending the legislative hearings at the capitol. The meeting closed at 7:07PM

2A Legislature news

STATE legislature:

H.B 5372 Amends law on possessing a firearm Rep. O'Neal and Rendon. This bill would add persons convicted of a misdemeanor involving domestic violence as prohibited from possessing a firearm.

H.B 5364 to 5367: Allow concealed carry; Reps. Beeler, Markkanen, LaFave, would amend several acts relating to the concealed carrying of a pistol with or without a concealed pistol license. Notably, the bills would remove the general requirement that a person obtain a concealed pistol license (CPL) in order to carry a concealed pistol in most places in the state. Under the bills, CPL licenses would allow their holders to carry a concealed pistol in areas that are now designated (with some exceptions) as pistol-free zones. **In committee analyzed by the Fiscal Agency.**

2A Legislature news Continued

Federal:

Note: There are dozens of bills introduced every year but few make it out of committee. This is a very short list that allows the reader to see the relentless attack on the 2nd amendment by the CPUSA and the few GOP bill to protect it.

HR 8 Universal background check bill was blocked by Senator Grassley when Senator Chris Murphy (D-CT) attempted to pass it using a back door method called "unanimous Consent" without any debate or a recorded vote.

HR 4238 MASS act Spencer Rep. Ayanna Pressly (MA-D) To provide grants to States to encourage the implementation and maintenance of firearms licensing requirements, background checks, limiting number of firearms allows and for other purposes.

S. 2319 3D Printed Gun Safety Act of 2021. Sponsor Senator Ed Markey (MA-D): Amends the US Code to prohibit the distribution of 3D printer plans for firearms.

S. 1522 Constitutional Concealed Carry Reciprocity Act of 2021. Sponsor John Cornyn (TX-R). A bill to allow reciprocity for concealed carry across states.

H.R. 2890 SAFER Voter Act Sponsor Rep Thomas Massie (KY-R) To reduce, from 21 years of age to 18 years of age, the minimum age at which a person may obtain a handgun from a Federal firearms licensee.

2nd Amendment news

Firearm ownership up: Latest estimates indicate that from 2020 to September 2021 11.6 million new gun owners were added. This despite the New American Communist Party (ACP), formerly known as the Democratic Party, demonizing gun owners, firearms in general and the right to self defense in the media.

Health Warning: CDC director Rochelle Walensky is pushing for studies on gun control to allow the CDC to claim gun ownership a health issue. There is no statistical evidence that "locking up" laws prevent violence. It does make one unable to defend themselves. Note it is illegal for a minor to carry a handgun concealed in Michigan. But democrats still believe more laws ,that criminals will ignore, will stop violence. (Anosognosia).

Fake News Dept.: CNN reports 641 mass shootings in 2021. That's almost 2 mass shooting a day. Their source: Gun Violence Archive, a known disinformation source used by the democrats. Editorial

Know your history or those that do know it will use it against you.

In the book, "Disinformation", by Lieutenant General Pacepa a former spy chief for the soviet controlled Romanian government published in 2013, he reveals how the communists have used disinformation to frame innocent victims that were in their way. 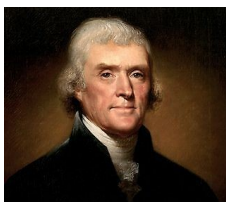
