2A Legislature news

Due to the Holidays not much was introduced during December

STATE legislature:

HB 4010: (Phil Green - R) Amends the General sales tax act by exempting sales tax on "gun safety items".

SB 22: (John Damoose – R) Amends the Aeronautics code of the state of Michigan making it a felony to possess a weapon in sterile areas of a commercial airport.

Federal:

H.R. 38 (Rep Richard Hudson-R-NC) "Concealed carry Reciprocity": Would make any state issued concealed carry permit valid in all states that issue permits. This bill will protect law-abiding gun owners like Shaneen Allen – a Philadelphia mother of two and concealed carry permit holder who was jailed for 48 days simply for driving across state lines into New Jersey.

H.R. 374 (Rep Matt Gaetz R-FL) "Abolish the ATF Act": Would abolish the rogue agency from making laws which they call "regulations". Only Congress can make laws. The recent "redefining" of pistol braces is just the latest example of the agency's violation of the second amendment. Rep. Gaetz says he will push for defunding the ATF if this does not pass. He is also calling for hearings on the ATF's overreach. (More and more 2nd amendment groups are pushing the abolishing of the ATF).

H.R 53 (Rep Bergman D-MI) "FIND Act" Forbids the federal government from entering into contracts with ab entity that discriminates against firearm trade associations or businesses that deal in firearms, ammo, or related products.

SHORT Act: (Rep Andrew Clyde (R-GA) "Stop Harassing of Rifle Owners Today" act was a 2022 bill H.R. 4986 Rep Clyde will reintroduce the act to repeal the pistol brace regulation which is a civil rights violation. He also will introduce a resolution of disapproval, under the Congressional Review Act to override the ATF's overreach in making what effectively is a law with a felony punishment. (Only Congress can make laws.)

2nd Amendment news

Bump Stock Ban Unconstitutional: The fifth circuit court of appeals ruled the ban a violation of federal law. The ATF had for years ruled that bump stocks were just an accessory, then literally over night the redefined them as a machine gun. The Chevron deference allow an agency charged with upholding a law to interpret any ambiguous parts of the law any way they want. As bump stocks were not specifically mentioned in the law defining machine guns they arbitrarily made them a machine gun. The ruling stated the ATF violated the Administrative Procedures Act by overstepping it authority and that only Congress could make owing bump stocks a felony. The supreme court ruled in the past that the power of punishment is vested in the legislative department.

Turn them in boys: Pistol Braces. In a reversal of past rulings the ATF has redefined pistol braces as short barreled rifles making thousands of lawful gun owners felons overnight. You have 120 days to register them as short barreled rifles or turn them in. As this is not an outright total ban like the bump stocks was, the courts may not reverse this violation of your civil rights as this is a tax. All you have to do is apply for a NFA tax stamp for \$200.00 send in a photo and fingerprints and fill out a form registering your short barreled rifle. A lawsuit brought by the Wisconsin Institute for Law and Liberty to stop this regulation on behalf of a group of former Marines.

Turn them in part II: Now 90 year old California Senator Dianne Feinstein is again introducing a bill to outlaw all modern sporting rifles (MSR). It specifically lists the banned modern rifles on 100 pages. It includes confiscation of large capacity magazines. (Wonder if her assistant who was outed as a Communist Chinese Spy, put her up to disarming the American public.) However by the supreme courts ruling common use firearms are protected. So what is common use? By looking at sales it is estimated 24 million MSR's are in use and some 273 million magazines are also in "common use". In a survey of 16,708 firearm owners, 66 percent of them said they owned AR15 rifles for target shooting, 61.9 percent said they owned them for home defense, and 50.5 percent said they owned them for hunting. The statistics for crimes committed will show only 2.2 percent of crimes are committed with rifles of any type. What is she afraid of?

Bill of Rights Insurance: A proposal by the democrats is to require liability insurance to exercise your 2nd amendment right. Next you will need insurance to speak words that may offend anyone.

Forbidden Knowledge: From a new paper from John Lott, 2% of Democrat Counties had 56% of the murders. 52% of US counties had ZERO murders. Those democrat counties had some of the most restrictive gun laws "to make them safer". Murders mostly occur in small urban areas. The democrats will state states with weaker gun laws have higher firearm violence <u>rate</u>. However those states are mostly rural with low population counts. So if there is a state with 100,000 population and they have 10 murders that is a rate of 10 per 100,000. But if you take California with a population of 40 million has 21,570 murders that rate is 5.6 per 100,000 (2020 statistics). So depending on how you present the facts you can make a small number seem huge. Figures Don't Lie, But Liars Do Figure ~ Mark Twain

Constitutional carry: Only the 2nd amendment right is infringed by the requirement to get a permission slip from the state government. 25 states have realized that if you are not a felon, mentally unstable, or a juvenile, you have a God given right to bear arms. Now Florida is joining the ranks of states that believe in your civil right to protect your self with a firearm. Those that are against this freedom are saying it will only make it easier for criminals to carry concealed. What makes them think criminals are following the concealed law today by getting a permission slip from the state to carry concealed to commit crimes? Only a defective mind or a completely evil one would come to that conclusion. Only 24 more states to go.

Gun confiscation doesn't work: New Zealand is three years into the semi-automatic firearms confiscation "buy back", to make the country safer. Some 56,000 firearms were turned in to the government and destroyed. Bad news is that gun crimes are up 53% from the last decade. Seems criminals didn't turn in their guns. Criminals like laws that disarm citizens. They can rob and pillage with no fear of some crazed legal gun owner shooting them. Go figure, who would have thought?

Weaponizing the Federal Trade Commission: Lying Senator Chuck Schumer is calling for the FTC to investigate firearm manufacturer for "illegally" marketing to minors. Never mind marketing to minors is NOT illegal. He wants to target ads for youth rifles used for target shooting training and firearm safe responsible use of firearms training. This is a well planned effort to stigmatize firearms in the minds of youth as the FTC did with their campaign against the tobacco industry.

Editorial
