2A Legislature news

As the legislature was off on holiday not much has been worked on.

STATE legislature:

2A Legislature news Continued

SB 550-553 and HB 5066-5069: makes it a 5 year felony to not have a locking device on your firearm or keep it in a secure location and a minor uses it to harm anyone or themselves.

Federal:

Note: There are dozens of bills introduced every year but few make it out of committee. This is a very short list that allows the reader to see the relentless attack on the 2nd amendment by the CPUSA and the few GOP bills to protect it.

HR 6225 A Bill to Modernize the Business Of Selling Firearms (Rep Robyn Kelly D-IL) Because of the high crime rate in Chicago this bill was introduced. At the time of this writing the text is not published on the House web page. (I wonder what they are hiding?) I suspect it will effectively destroy gun dealers through red tape. Kelly's web page admits it will require dealers to fortify their stores from theft, "clarify" standards of dealers and their employees, repeal all laws requiring the privacy of the FFL forms you fill out to buy a gun, full electronic data management of gun purchase records. It also include reporting of two or more shotguns and rifles purchased over five days, Prohibit purchasers for indictment of crimes (never mind due process and the assumption of innocence), and all employees of dealers undergo background checks for renewal of FFL (never mind that they have had no violations, more you are guilty until proven innocent).

2nd Amendment news

NY Law bypasses Federal law: The "public nuisance law" allowing anyone to sue the manufacturers for misuse of a firearm is being opposed by the National Shooting Sports Foundation and 14 manufacturers. They have brought a lawsuit in federal court and mover for a preliminary injunction. They argue the law violates federal law, (the Protection of Lawful Commerce in Arms Act) the commerce clause and is vague. The State claims manufacturers are liable for the misuse of their products. (Think Ford will be sued for the misuse of the SUV that killed six and injured 62 at the parade marchers in Waukesha?)

Fake News Dept. 1 Rutgers University researchers report that the people buying guns for the first time, during the surge of gun purchases, are unique from previous gun buyers in that they "have difficulties with impulse control". (It has nothing to do with "defund the police, BLM and ANTIFA riots, nor rampant crime in socialist run cities.)

Fake News Dept. 2 Newsweek reported Trump supporters in the military are planning an insurrection in 2024. And that there are "millions of angry armed Americans that stand ready to seize power if Trump loses in 2024."

I Can't Make This UP Dept. Kim Foxx Chicago's (Soros funded) prosecuting attorney stated that rival gangs having a shootout in the city is allowed under her "Mutual combat" interpretation of the law, as both parties were willing to take part in the shoot out. She has also dismissed charges of murder of a 17 year old that stabbed an 18 year old to death based on "mutual combat". (Me thinks she should ask for a refund from the school that gave her the law degree).

I Can't Make This UP Dept. part II: Washington State Democrats introduce a bill to reduce drive by shootings from 1st degree murder to aggravated murder and reduce the penalties. This is being done under the pretense of racial equity. While at the same time they introduce bills to disarm law abiding citizens. One democrat proposed to ban private autos as he claims is if all we had was public transportation these drive by would not happen.

Know who you donate to: VoteVets is a political Action Committee (PAC) that sounds like it supports veterans to run for political office. It in fact is an anti second amendment group that only supports anti-gun candidates. A major portion of their funding comes from Bloomberg and the Democratic party. Most is spent on smear ads in the media.

Fake News Dept 3: USA Today headline " Down the barrel of a gun: How the second amendment can be a gateway to extremist ideologies" Using the Saul Alinsky rule #5 taken from the KGB disinformation handbook Ridicule an dismiss as unfounded the idea that the government is intent on removing the 2nd amendment. Slipped by: The local TV news had an article that FFL dealers must now certify they have firearm securing devices available. This was a Notice of Proposed Rule Making from 2016. The ATF stated only 4 responses were received. Many manufacturers have supplied locking devices with every gun for years. So this is now an ATF rule which can penalize FFLs (including manufacturers, importers, and pawn brokers, that sell to non FFLs) that do not have these device available. Also in this, if I read it correctly, is the redefinition antique firearms making all black powder firearms "antique" now under this definition even one manufactured this year. This becomes effective Feb 3, 2022. (see the Federal Register of Tuesday Jan 4, 2022 / rules and regulations)
