2A Legislature news

STATE legislature:

SB 76, 78 Universal gun registration

SB 208 Eliminates the preemption of local firearm laws, allowing local authorities to enact their own firearm laws. (Known as the right to create "massacre zones" law AKA gun free zones.)

HB4185 would prohibit unaccompanied minors using or possessing certain BB guns outside of their property. Still in committee.

Federal:

HR615 Rep. Rob Wittman's (R-Va.) Would require scientific data that demonstrates that lead ammunition and tackle is detrimental to wildlife BEFORE prohibiting the banning of lead in these products. The Biden regime's Fish and Wildlife Service insists that they instinctively know lead is harming wildlife and therefore no science is needed.

2nd Amendment news

Michigan CPL licenses have reached a high of over 800,000. The Democrats plan to disarm law abiding citizens, and protect criminals from prosecution, is prompting the increase.

They just can't stop lying about the AR15. NBC hit piece lied about the AR15 having originated with the military. The Armalite rifle (AR10) was designed in the 1950's for sporting use. Being a new novel design that had many good features the military asked the inventor to make a military version of it (full auto M16). They also stated the AR15 was a military rifle, oops another lie, the semi-automatic AR was NEVER used by the military. Next lie: Clinton's "assault weapons" ban reduced mass killings, the DOJ however reported it had no determinable effect. They hope that if they keep lying the uneducated public will believe these lies (echos of Goebles).

Detroit passes resolutions to have the state pass SB 208 and create "gun free zones". Detroit democrat consul members are absolutely positive the criminals will obey this law.

Democrat Senator Michael Bennet proposed a bill to create a new federal agency to control "misinformation, hate speech and any speech the government does not approve. (Hmm where have I heard of this before?)

13 new gun restrictions proposed by the Biden regime: banning "assault weapons" (not define what these are), gun storage laws, background checks for all gun transfers even private sales, allowing gun manufacturers to be held responsible for the misuse of their products.

ATF in trouble?: The Citizens Committee for the Right to Keep and Bear Arms asked Congress to fully investigate allegations of "substantial waste, mismanagement and unlawful employment practices at the agency. Two whistle blowers allege the ATF paid non-law enforcement personnel law enforcement pay and other malfeasance.

Surprise 88% of Democrats are anti-civil rights: NPR-PBS poll shows 88% of democrats want parts of the bill of rights removed starting with the 2nd amendment. Maybe the 1st amendment is second to be removed. (Remember it was the Republicans that passed the civil rights law back in the 60's).

Pistol Brace injunction clarification: The court issued a clarification that the injunction applies to all members of the Firearms Policy Coalition (FPC) and customers of Maxim Defense. Time to join the FPC. Second Amendment Foundation (SAF), Gun Owners of America (GOA) and Firearms Accountability Regulatory Coalition (FRAC) all have cases pending in different court jurisdictions. Stay tuned for more.

Now the Second Amendment Foundation has won a court challenge. If you are a SAF member you are covered by this injunction and can keep your brace for now.

Rep Andrew Clyde (R-GA) Forces a vote on Resolution to Disapprove the pistol brace rule. He faces a tough challenge as the RINOs in congress will not support this. If passed the ATF brace rule is null and void.

Never let facts get in the way: As more anti civil rights states like Michigan ban 18, 19 and 20 year olds from possession of a firearm or obtaining a CPL, they totally ignore the fact that FBI data shows this group, which has undergone a background check, has lower arrests than those over 21. They also ignore the fact that the criminal gang bangers never have a background check. The stats for Michigan's revocation of CPL's for ALL ages .0,26% which makes them one of the most law abiding group.

Laws for thee not for me: The ATF reiterated that marijuana use and firearm ownership do not go together. Doing so is a federal crime. Democrats are allowed to break the law, Hunter Biden lying about drug use on form 4473, and the chair of FL democratic party Nikki Fried using cannabis while owning a firearm. A clear violation of the ATF rules. Nikki bragged about pulling the CPLs of attendees to Jan 6 while she was in charge of the FL CPL system.
