## 2A Legislature news

### **STATE legislature:**

**HB 5658** (Reps Hood and all democrats), Would add a seven day waiting period for all pistol purchases. (Never mind all the states that have waiting periods prove it has no effect on homicides).

**HB 5677** Sponsored by Rep Stone and democrats, Would require **ALL** persons selling a firearm must provide a trigger lock or other device to secure the firearm, or a lockable case, a brochure that has safety information, and retain a signed document attesting these have been provided. If this rule is not followed the seller can and will be held responsible for any harm that firearm may cause. (now only a federally licensed dealer has to provide these devices and brochures).

**SB 0856 & SB 0857:** (McMorrow-D) **Red Flag Law** would allow anyone to file a form with the state court administrative office that would allow confiscation of firearms from anyone suspected of being an extreme risk to himself or others. The court could issue this confiscation without notice to the accused. A hearing will be held within 14 days

**HB 5677** (Rep Lori Stone-D) All firearm sales even from a private individual must include a trigger lock or other device designed to disable the firearm.

**HB 5841** (Joe Tate-D) Appropriates 10 million dollars to the university of Michigan for firearm injury prevention studies.

### **Federal:**

**SB 675** NICS Denial Notification Act (Senator Coons D-DE) Requires the DOJ to notify state and local law enforcement following a firearms related background check that results in a denial. The NICS system routinely denies innocent citizens the right to purchase a firearm due to it's faulty search algorithm. This is sometimes caused by the honest citizen that happens to have a name the same as a criminal. Government records show 90% of denials are false positives.

## 2<sup>nd</sup> Amendment news

**Surprise news: Biden Lied:** Biden's rant against "rogue" FFL dealers that they are responsible for criminals getting guns was a complete lie. The Second Amendment Foundation sent a FOIA to the ATF is asking for the numbers of dealers prosecuted for supplying guns to criminals. After 4 months they responded that they need more time to respond. Four months more passed and the ATF responded that "they don't know how to handle the request". (I suspect the numbers are so low that it would prove Biden lied.) Unfortunately there is no way to force a rogue federal agency to comply with the FOIA law other than law suits.

**The Biden Regime insanity:** The response to innocent citizens being victims of crime is to disarm the innocent victims. Democrat Governors like Connecticut's Ned Lamont believe they are too lenient on guns not criminals. He believes that the high crime rate is caused by the high gun sales in his state. So he proposed to license all legal gun owners in the state. (He really does not care about the criminals owning guns they are exempt from licensing).

**Welcome to the "resistance"** Biden's speech in New York lumped all law abiding gun owners into the "resistance". He claims that this "resistance" is the cause of the rise in crime in our cities. So he just lumped an estimated 115 million gun owners into a "resistance" movement that is preventing his regime from passing draconian gun laws. The leaders of this "resistance", according to Biden, are the firearm industry and they must be held responsible. Strange he never mentioned holding criminals or the Soros bought prosecutors as responsible for the crime increase.

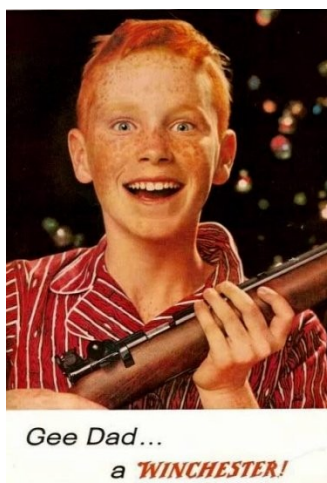
**January gun sales:** another record. Even though the January 2022 numbers were down from 2021 it still was one of the highest on record: over 2.5 million NICS checks.

**Good Bye Freedom of Speech:** Five neo-Marxist democrats (Blumenthal, Murphy, Markey, Menendez, and Booker) are pressuring YouTube to censor any videos that feature firearm assembly. They deemed it an extremely dangerous content. (Never mind the Jihadists can still post anti-American videos). Making firearms at home has been a civil right since before the country was founded. These senators state that these home made guns are the cause of upsurge in "gun violence". Show me the statistics please.

**Biden's plan to disarm America:** He has stated that he plans to ban ANY gun that has a capability of taking a magazine that can hold over 10 rounds. That means even if your hunting rifle uses a 5 round magazine, it will be banned as you could buy a magazine with a capacity larger than 10 rounds. Now that the Biden Regime has 900 million plus gun transactions in a database, they will be able to track down anyone who has purchased a banned firearm.

**Who commits gun crimes:** A study by the D.C. metro police and the federal Criminal Justice Coordinating Council found that the Pareto Principle applies to crime. (80% of consequences comes from 20% of the causes) They found that 500 individuals commit 60-70% gun crimes. 86% of the victims and suspects were known to the authorities. BUT to use this information the authorities must "profile". They would also have to be tough on the crimes the suspects commit BEFORE they commit a gun crime. And in another surprise other studies found that crime is concentrated in certain neighborhoods.

**Coming to a state near you:** California attacks the 2nd amendment through the 1st amendment by prohibiting firearm manufacturers from supposedly marketing to minors. Below is a 1943 Winchester ad and a Remington ad that would be banned under this rule. So I must ask: did the gun change or did our moral values change?
