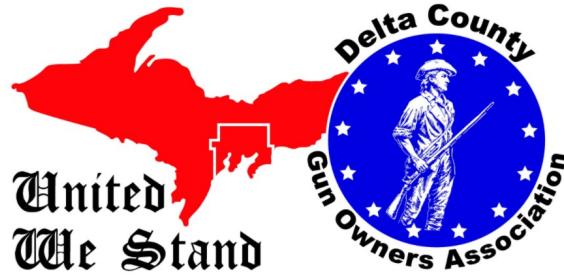


DCGOA MAY 2022 NEWSLETTER

DCGOA NEWS

Notes from the April Meeting:

Bob opened the meeting at 6:30PM with the pledge of allegiance. After the treasurers report and the secretary's report, a report from the banquet committee was given, A report on the Biden gun control agenda was discussed. It was announced we need conservative candidates for the Delta county board.

2A Legislature news

STATE legislature: All bills introduced that were mentioned in the April newsletter are still in committee. (House Bills 4078, 5873, 5883, 5903, 5907, 5947)

No new bills pertaining to the 2nd amendment.

Federal:

HR 6945 Rep Michael Cloud (TX-R) "*No Retaining Every Gun In a System That Restricts Your Rights Act*" Would require the ATF to destroy all transaction records after 20 years as the existing law requires. It also would require FFLs to destroy their record when they go out of business. The Biden regime want to keep these records and create a defacto registry of firearms. No bill number assigned at the time of printing.

HR 7366 (Ronny Jackson TX-R) "No User Fees for Gun Owners Act" Prevents any state or municipality from enacting a tax, user fee, or equivalent financial measure on firearms. States and Municipalities can mandate auto insurance for car owners and several are considering the same mandate for gun owners. San Jose CA has passed this. (Whats next a fee to exercise all of our rights guaranteed by the constitution?)

2nd Amendment news

ATF has issued the ruling on the definition of "Frame or Receiver" and Identification of Firearms. This rule is 98 pages long. This ruling re-defines what a firearm is, a gunsmith, a silencer, and the word "readily". The goal of the ATF is to define a firearm as anything that can be "readily" made into a firearm as a firearm. They claim that un-serialized Guns (their term is "ghost guns") are used in the epidemic of crimes we are experiencing. Note that until the National Firearms Act of 1968 firearms were not required to have a serial number. So any firearm confiscated in a crime with out a serial number either because it was manufactured before 1968 or had it illegally removed, as well as personally made firearms are lumped into the "ghost gun" category.

They now define a "firearm" as anything that can be readily made to expel a projectile by action of an explosive. "Readily" is defined as "a process that is fairly or reasonably efficient, quick, and easy, but not necessarily the most efficient, speedy, or easy process." Purposely vague to it can be interpreted broadly. By this definition any plumbing pipe that a cartage can be fitted into is a firearm. (Sure glad we have a 2nd amendment that prohibits the government fro **infringing** on right to keep and bear arms.)

The University of Michigan researchers stretched the truth by redefining a "child" to report that more children are killed by guns than motor vehicles. They did this by defining a child as individuals up to 19 years of age. Conveniently this brings into the definition of "child" many criminal gang members. If the definition is reduced to those under 17 years, vehicle deaths are the leading cause of death.

Editorial

Biden gave 176 artillery pieces 64,363 belt fed machine guns and 126,295 handguns and 358,530 select fire assault weapons equipment with enhanced optics to the Afghanistan terrorists,. Also allow suing politicians if you are denied the right of self defense by restrictive gun laws and you get attacked by a felon.
