Notes from the October 11th Meeting: After the Pizza dinner, and a surprise birthday cake for a member who shall remain nameless, Brian opened the meeting at 6:45PM. The secretary report and treasurers report were approved. Under old business the Jim Groos Scholarship fund application was discussed. Under new business the school guardian dogs was discussed along with the Honor Flight and the Wheelin Sportsman for Grants. Meeting closed at 8:45PM

2A Legislature news

As all politicians were in election mode little was done in the legislatures, state or federal.

STATE legislature:

HB 6432: (Steckloff-D) Amends the penal code to add the requirement that a CPL holder to immediately disclose to a firefighter, or emergency services personnel when encountered in their official capacity he is carrying a firearm or electro-muscular disruption device.

HB 6447: (Rogers-D) Would deny possession of a BB gun or pneumatic gun by anyone less than 18 years of age outside the curtilage of the home unless accompanied by an individual over 18 years of age.. This would be a fine of \$500.00

SB 0678: (Chang-D) Amends the penal code to deny 2nd amendment rights for 8 years to anyone convicted of a misdemeanor involving domestic violence.

Federal:

The "**Bipartisan Safer Communities Act of 2022**" is now law. Starting November 14th this bill, supported by 15 RINOs, requires enhanced background checks of 18 to 20 year olds. It may take up to 10 days for the enhanced check to be completed.

House Resolution 1436: Tenney (R-NY) Resolves that NY state Concealed Carry Improvement Act is unconstitutional. (A warning to other states that are waiting to see if New York can get away with this)

2nd Amendment news

It's now law, H.R.1222 Target Practice and Marksmanship Training Support Act. AKA the "Range Bill" (Rep Ron Kind D-WI) was passed way back in May 10th 2019 allows a state to use federal funds to cover a percentage of the costs for the construction and expansion of public target ranges. Specifically, a state may use specified federal grant funds to pay up to 90% of such costs (rather than 75%, as under current law). Additionally, amounts provided for these purposes shall remain available for five fiscal years (rather than two, as under current law). These funds come from excise taxes on firearms and managed by the Wildlife Sport Fish Restoration Fund Program. Now we need the "Range Access Act" by Rep. Blake Moore to be passed. It would require a public shooting range in every National Forest. We need a public range here in Delta County. Where is the money that has been allocated?

Judge rules on altered or removed firearm serial numbers: A federal district judge in West Virginia ruled unconstitutional the federal law making the possession of a firearm with a removed or altered serial number a felony. Using the recent supreme court ruling and applying the intent of the constitution he found it did not require serial numbers on firearms when it was written. The government would have to provide proof that the 2nd amendment required serial numbers when it was written. Essentially, if the Founders were not regulating it at the time that the 2nd Amendment limited the federal government's authority, then legislatures today have no constitutional basis for regulating the same conduct today. Expect the Biden regime to appeal.

UN Arms Trade Treaty: The Biden regime will give up the US sovereignty to the UN with this ban on citizens owning firearms through restriction of trade. The UN believe if trade in firearms is stopped a more peaceful world will be created. The UN ignores the fact that this ban didn't work in the Ukraine, and ignored the fact it is governments that conduct wars, and that they can not stop the black market.

The Supreme Court' Bruen decision Is being used by pro second amendment groups to challenge state laws that infringe on the right to keep and bear arms. Hawaii lost it's case regarding "keeping a firearm in a proper place". Maryland is being challenged on the requirement for carry permits. Illinois is being challenged on their firearm owners ID card. Maybe Michigan will be next.

Still More Push back on the "woke" financial institutions. Missouri pulled \$500 million from BlackRock because of BlackRock's ESG principles. South Carolina, Louisiana, Utah, and Arkansas will also pull funds out of BlackRock. That's over 1 Billion dollars. As banks like Wells Fargo, J.P. Morgan Chase, Bank of America have denied funding to firearm related businesses, it is time for freedom loving Americans to pull their funds from these banks. American Express, Mastercard, and Visa are flagging all firearm related purchases. Do you want to fund these cards that want to deny your rights?.

The FBI is monitoring social media of firearm owners for alleged violent threats. Never mind that the FBI ignored the social media threats from the perpetrators of all the school mass murders. When the FBI shows up at the alleged terrorist, they are asked to voluntarily sign a "self-submission" form, waiving their right to the privacy of their mental health. As this is a clear violation of the law, (see HIPPA privacy act 1974) the Gun Owners Of America has filed a law suit to have these records destroyed. There has been no response from the FBI. Now Congressional republicans are demanding an answer from AG Merrick Garland and FBI director Christopher Ray. (Don't hold your breath on this one.)

Project Unloaded is an anti 2nd amendment organization that has started a campaign targeting teens and young adults to create the idea that guns make us less safe. (This as the Democrat attorneys general have instituted a catch release program to increase crime.) There is a lot of money being applied to this campaign from several liberal funds. The idea is to use propaganda aimed at our youth that guns are the evil in society that causes crime. Some contributors to this dis-information group is the McArthur Foundation, the Joyce Foundation, and others. (I wonder if their "Safer Not Using Guns" campaign will resonate with the gang banger drug dealers in the inner cities.)
