Notes from the September Meeting: Bob opened the meeting at 6:41 Larry read the minutes from the board meeting and the August meeting which was approved, Rich gave the treasurers report it was approved. Rich reported we had record year for money collected at the fair. We signed up 29 new members. Bob reported on the advantages of starting a Political Action Committee locally to influence local elections like county board, school boards etc. We will have the Airsoft booth at the Great Lakes Sportsman club Youth Day and need volunteers. Bob reported the resolution to be brought before the county board to limit the mandating of masks and vaccines will be brought up at a future board meeting. Petitions to limit the state health department's mandates to 28 days and then require the state legislature to act to extend it are being circulated. You can find them from DCGOA members and at Old Glory Firearms in Gladstone. Paul gave a report on the status of the web page. The domain name was suspended due to lack of payment. The credit card that the payment was to be debited to had expired. Rich worked with the domain name manager to clear up the issue and renew the names for 3 more years.

Notes From the Second Amendment March in Lansing. DCGOA was represented at the march by Bob Petersen, Larry Johnson and Paul Cavallaro. It was a cool (47degrees) and moist (constant rain) and windy (20 MPH gusts) day. This year was not one for fair weather supporters! I would guess 200 hardy souls attended. Several vendors of accessories and providers of legal protection services had tables under the big tent. Joel was master of ceremonies again. There were many speakers that talked. Great Lakes Gun Rights' (GLGR) Brenden Broudreau mentioned two bills one in the senate and one in the house were introduced for constitutional carry. There were candidates running for governor that also spoke. NO state representatives or senators showed up. It was a Thursday and they don't work past 12 noon as they take off home for the week end. Tom Lambert from Michigan Open Carry spoke. Mary Schuster-Callison spoke on how her sister was brutally attacked and why we need the right to defend ourselves. She is co-chair of 1 million moms **AGAINST** gun control. Rick Ector from Legally armed in Detroit spoke. Mark Walters from Armed American Radio spoke. He is also affiliated with Ammoland News. Doug Giles host of ClashRadio.com spoke of the feminization of our men and boys in this culture. Many more inspiring speakers were there.

2A Legislature news

STATE legislature:

HB 4718: (passed in the house) Amends the law to allow application for a CPL to the county clerk outside the county of residence, unless that clerk does not accept applications from other counties. Previously you could only apply in your county of residence. **In Senate Committee.**

HB 4866: Clarifies carrying a loaded firearm while in areas of wildlife. **In Committee.**

HB 4957 & HB 5187 & HB 5188: Clarifies the emergencies Management act to NOT authorize any of the seizure, taking, or confiscation of lawfully possessed firearms or ammunition nor does it ban the sale or purchase of firearms or ammunition. **In Committee.**

HB5066: Requires any seller of a firearm to deliver a written warning to the purchaser the penalties for failing to store or leave a firearm in a manner required by law. It further defines exactly what the "safe manner" is. It provides punishment for the firearm owner should a minor access the firearm for any reason. If the minor causes injury or death the owner is guilty of a felony. Exemptions are made for farming, employees, parents permission, instruction, and target shooting. If the firearm is secured per this law and is obtained via unlawful entry this law does not apply. An exemption is made for self defense. **In Committee.**

HB 5067: Proposes "The state of Michigan has exempted the sale of firearm safety devices from the sales and use tax imposed by this state through December 31, 2021." **In Committee.**

HB 5271 Sponsored by Rep Bellino (R) modifies the CPL law to allow one to submit the CPL application not only to the county clerk in which one resides but also to a contiguous county or to a county where his business resides.

HB 5312 and SB 0646 Sponsored by Rep Maddock (R), Senator Barrett (R) would change the pistol licensing law to remove the requirement for registering a pistol and require all records be destroyed. This is a step to constitutional carry and removes the pistol transfer of ownership (registration) requirement. Great Lakes Gun Rights and Michigan Open Carry helped get this bill introduced.

Federal:

H.R. 4953 Sponsor Rep, Ted Deutch (FL-D): National Firearms Amendments Act of 2021. Amends the NFA to ban any semi-automatic Rifle that has a detachable magazine. They must be surrendered to the government or registered as if they were fully automatic machine guns with applicable taxes paid.

H.R. 3101 Sponsor Rep. Ashley Hinson (IA-R): RIFLE Act (**Repealing Illegal Freedom and Liberty Exercises Act**) would repeal the \$200 tax on the transfer of short-barreled rifles, shotguns, machine guns, silencers and "destructive devices". This is in the 1934 NFA enacted during FDR's administration.

H.R. 127 Sponsor Rep. Sheila Jackson (TX-D) Sabika Sheikh Firearm Licensing and Registration Act. Requires licensing to possess all firearms and ammunition. Requires all firearms to be registered. Would prohibit certain ammunition. Require all firearms owners to be psychological evaluation. Bans any rifle that looks like a military rifle. Outlaws .50 caliber or larger ammunition. Bans any magazine larger than 10 rounds. Violation will bring a 10 to 20 year sentence.

H.R. 4350 NDAA National Defense Authorization Act funds the military but has provision to allow the confiscation of firearms owned by those in the armed forces. It also has a provision to stop small manufacturers of firearms from exporting their products. Congressman Bergman opposed the red flag provisions and says the Senate will strip it out of the bill. **Passed in the house.**

H.R. 5245 Gun Trafficker Detection Act. Sponsor rep. Casten (D-IL). Requires 48 hours to report a stolen firearm to the attorney general. Penalties range from \$1000 to \$5000.

H.R. 4836 Firearm Owners Responsibility and Safety Act. Sponsor Rep. McEachin (D- Va) requires all firearms to be secured if not in your immediate control.

Violence Against Women Reauthorization Act (VAWA). A centerpiece of the Biden regime's gun control plans. This creates federal grants to confiscate guns giving funds to states that pass red flag laws. It will fund a special enforcement anti-gun police unit to carry out the confiscations. Bad news is that many republicans in the senate are on board to pass this.

2nd Amendment news

2021 National Firearms Survey preliminary results report that since 2019 nearly half of new gun owners during that time were women. 3.5 million women vs 4 million men from April 2019 through April 2021. Hence the need for classes orientated to women.

Ammo Inc. (www.ammoinc.com) announced it is building a new ammunition manufacturing plant in Manitowoc Wisconsin. They will manufacture brass cases, and bullets in house, but will need to source powder and primers. Primers continue to be the bottle neck in the production of ammunition. If the U.S. gets into a shooting war the military will soak up all the components making it harder to find ammo. Stock up now.

Fake News Dept. CNN praises the Communist China on their gun control policies, ignoring the human rights violations in that regime. They praised the low gun crime rate and ignore the government sponsored killings of anyone who opposes the regime (estimated in the thousands). China Central Television hosted Biden's ATF nominee David Chipman where he attacked the 2nd amendment in America. (*Hmmm Chipman forgot to disclose that interview during his nomination hearings...wonder why? Useful Idiot.*)

Why you need to carry dept. The FBI Uniform Crime Report for 2020 indicates that armed private citizens killed more criminals in the act of committing a felony than the police. When second count the police are minutes away and in some cases hours. Armed citizens killed 343 vs 298 for police. You are the first responder when you or your loved ones lives are in imminent danger. Ask any anti-2nd amendment politician why they pay someone else to carry their gun (private security) when they say the police are there to protect you so YOU don't need a gun. Also the FBI statistics released this September, show murders have increased by almost 30%. 
