Notes from the August Meeting:

Bob opened the meeting at 6:30PM. After the secretary and treasurers report, the sign up sheet for the fair was circulated. We still need volunteers to work on the scholarship application.

Sept 18 is a hunter safety class at the Mead Rod and Gun Club. A discussion was held on the suppression of civil rights by the government due to the pending legislation in congress (See HR 1808). We must get all conservatives to vote this fall to preserve the bill of rights.

Looking forward: Now that the U.P. State Fair is over, DCGOA is now planning the 2023 banquet. We want 2023 to be the biggest and best banquet ever. 2A Legislature news

STATE legislature:

HB 6352: (Sneller-D) Allows tax credit of up to \$350.00 for the purchase of a firearm safety device.

HB 6353 (Harris-R) Amends tax bill 1967 PA 281 to allow a tax deduction for the amount paid for a gun owner liability insurance policy that provides legal protection for the use of a lawfully purchased firearm.

Federal:

H.R. 8740 (Maloney D-NY) Firearm Industry Crime and Trafficking Act. This would hold accountable manufacturers for “flooding communities with weapons of war like AR15s”.

H.R 8760 (Morelle D-NY) State Firearms Dealer Licensing Enhancement Act. This would give grants to states that license firearms dealers. This would add another layer of bureaucracy over federally licensed firearm dealers. (And more taxes and fees).

2nd Amendment news

Suppressing the 1A to attack 2A: In violation of the bill of rights the California legislature has passed a bill (2571) that prohibits advertising or marketing firearms, in a manner that they determine is marketing to minors. If this passes the court challenge expect it to be tried in other states. And it provides for penalties for any law firm that defends this violation of the 1st amendment. This effectively silences any debate on the subject. (Stalin would be proud). (See the end of newsletter for examples from the past that would be banned today).

Lier in Chief: Biden again, in front of a crowd states you can't own a cannon. Again he states he will ban “assault weapons” (Which has not been defined) and is unconstitutional. He claimed the gun ban of 1994 stopped crime. The 2021 report from FactCheck.com says there was no appreciable change in crime numbers. He did promise a war on all gun owners that have semi-automatic firearms. He stated a bullet out of an AR travels 5 times faster than any other rifle. He said he is not coming for your guns, yep he isn't, he's sending the ATF for your guns.

A Judge in Texas has struck down a law that prevented 18 to 22 year old's from getting a CPL. Seems the judge read the constitution and found it has no age limit on the 5th and 14th amendments. There is precedent from some courts that the bill of rights is fully vested at 18.

Unlawful Laws: NY state's governor in violation of the constitutions has pass a law that: Banned the sale of body armor to civilians, Required one to obtain a license to purchase a semiautomatic rifle (one must be 21 to obtain the license), Expanded the state's confiscatory red flag law, Criminalized the sale of firearms that do not have microstamping technology, Removed the grandfather clause for magazines of a certain capacity purchased prior to the passage of the SAFE Act, Forced gun shops to adhere to uniform security and reporting standards, Established a new task force on “Social Media and Violent Extremism”, Required background checks for ammo sales as well as creating a statewide ammunition license and database. We must vote out over reaching dictator constitution hating politicians this November!

Editorial

Never before in our country's history have our civil rights been trampled upon to the extent they are now. Through the government's proxies of social media the freedom of speech has been suppressed. There is evidence the Biden administration colluded with social media to violate the first amendment of conservatives. There is precedent in supreme court decisions that this is unconstitutional. Through threats of financial reprisals the government is coercing financial institutions not to do business with firearm manufacturers and sellers. This is a gross violation of the constitution. The ATF is knocking on doors asking for gun owners to show them their firearms, a violation of the 4th amendment. President Trump's invasion of his home is another violation of the 4th amendment. It specifically states the place and things to be searched must be specified. But Biden says the Trump supporters are "semi-fascists".

I am deeply offended by Biden calling the children of WWII veterans who fought against fascism, fascists because they don't believe in the America the Communist Party of America wants. Biden's policies that he hopes to enforce against the second amendment are very close to what Hitler did in the 1930's; so who is the real fascist?. He is calling for the banning of "assault weapons" which if you read the House bill 8018 is anything they deem them to be. How can a Ruger Mini14, which shoots the same ammunition as the AR15, and is a semi-automatic, so different that it is not an "assault weapon"? Oh, it has a wood stock. Don't tell anyone but there are after market stocks which make the Mini14 look like an AR. Maybe someone told the Biden handlers that wrote the bill, that a wooden stock slows the bullet to travel less than the 5 times faster than a plastic AR15 shoots it. (BTW the .220 Swift runs at over 4000 FPS while a .223 from an AR runs around 2700 FPS.)

More citizens are realizing that just like Vladimir Putin did in the Ukraine to instigate a war by using a false flag op. Biden is running a false flag op against the "semi-fascist" MAGA citizens and gun owners.
